**Contemporary Art Center of Peoria's Artist Member Group Exhibition
at Decatur Area Arts Council's Anne Lloyd Gallery, in Madden Art Center**

Exhibition Prospectus

Eligibility: The exhibition is open to all artists currently enrolled with an Artist membership level of \$50 or any higher level of membership with the Contemporary Art Center of Peoria. There is no additional fee except for a current membership.

Entries: Since exhibition space is limited, exhibitors are limited to one entry per artist. Each artist chooses what to enter. Entries are not chosen via a jury process. Artwork must have been created in the last three years and not been displayed at a prior CAC Artist Group Membership Group Exhibit. Artwork that is for sale is preferred.

Subject Matter: Subject Matter for this exhibition is left to the discretion of the artist. Host gallery staff and owners may choose to reject work based on their own criteria. The host gallery prefers family-oriented content.

Media: Only original two or three-dimensional artworks of various media will be accepted. No reproductions are allowed. Video artists must bring their own equipment and deliver it.

Condition: All work accepted for the exhibition must arrive ready to install. Works not ready for display, with poor craftsmanship or presentation, may not be exhibited. Wire is preferred on the back of artworks intended to hang on a wall. Unstable 3-D works will not be exhibited. Identification Tag *must* accompany / be attached to artwork.

Judge for Awards: At each exhibit, a qualified judge selects ribbons and monetary prizes for the award categories listed below. The judge for this exhibit is **Jennifer Holt**, Assistant Professor of Art at Millikin University. She will choose to award 5 of the works entered by participating artists. DAAC staff will choose an award also. Judging will begin once the exhibit is fully installed. Ribbons will be displayed before 5:00 on September 2 and/or announced that evening.

Awards:

Best of Show:	\$250 + ribbon
1 st Place:	\$150 + ribbon
2 nd Place:	\$100 + ribbon
3 rd Place:	\$50 + ribbon
Honorable Mention:	ribbon
DAAC Staff Pick	ribbon

Online Registration: An **Exhibitor Registration Form** must be digitally submitted on www.peoriacac.org via <https://peoriacac.org/registration-form/>. This link and all information can also be located in 'Upcoming Exhibits' on the website. Registration for group exhibits is now by digital means only. Contact Contemporary Art Center staff if there are obstacles to submitting online.

- Registration Deadline:** **August 19** - All online registrations must be submitted online no later than Friday, August 19 by midnight.
- Identification Tag:** Each identification tag can be filled in online and printed out to accompany / attached to artwork when dropped off. A tag may also be filled out manually if artists deliver art to the Contemporary Art Center.
- Delivery Option #1:** **August 26**– CAC staff/volunteers may deliver artwork to the venue. All submissions requiring courier service to Anne Lloyd Gallery must be delivered to the Contemporary Art Center of Peoria no later than 5:00 on Thursday, August 25. The following are drop off dates and times: 11-7:00 on August 18 and 19; 11-5:00 on August 20, 23, 24, 25. Please package and protect the work with stacking and transport in mind. Name of Artist should be on packaging in multiple places. Contact Contemporary Art Center staff for alternate drop off times.
- Delivery Option #2:** **August 26 or 29** – Artists may deliver their work directly to the Anne Lloyd Gallery by appointment 8:30am - 4:00pm on either Friday, August 26 or Monday, August 29. All artwork must be at Anne Lloyd Gallery by 4:00pm Saturday, August 29. Late deliveries may be rejected. An identification tag *must* accompany / be attached to artwork.
- Insurance:** Anne Lloyd Gallery provides insurance for art for theft and damage while on the premises. There are security cameras and staff on duty at all times.
- First Friday Reception:** Contemporary Art Center of Peoria and Anne Lloyd Gallery will celebrate all participating artists during their First Friday 5-7:30. At 6:00pm, award winners will be announced and representatives will speak. The public is invited to attend this event.
- Viewing Hours:** Regular viewing hours are Monday - Friday 8:30am - 4:30pm and Saturday, 10:00am 2:00pm. There is no charge for admission for the public to view the exhibit.
- Sales:** Anne Lloyd Gallery will handle all sales and take 35% commission. Commission checks will be sent 30 days or less from the last day of the exhibit. In the event of a sale, it is the responsibility of the artist to pay 9.25% sales tax to the state. The gallery will not collect sales tax or report the sale. (If an artist wishes to alter their price to accommodate paying tax, multiply .0925 x retail price to determine potential tax amount)
- Artwork Retrieval:** **Artwork delivered to Decatur by CAC staff** will be returned to Contemporary Art Center of Peoria and be available for retrieval at CAC on the following dates and times: 11-5:00 September 30, October 1, 4 & 5. October 6, 11-6:00, October 7, 11-8:30, October 8, 11-5:00. Contact Contemporary Art Center staff for alternate retrieval times.
- Artists that delivered their work** to Anne Lloyd Gallery may begin retrieval from the Decatur gallery by appointment only on September 29 and 30, 8:30am - 4:30pm, or Saturday, October 1, 10:00am - 2:00pm.
