A group exhibition of loaned works in Contemporary Art Center's Preston Jackson Gallery

Exhibition Prospectus

- Eligibility:** The exhibition will be open to any works by Ken Hoffman. Artwork must remain on display for the entire duration of the exhibition.
- Media:** Original two or three-dimensional artworks of various media will be accepted. Fragile or damaged art will not be accepted. Artworks that are intended to hang on a wall must be ready for hanging. A wire hanger for 2-D work is preferred. 3-D work that is not stable will be rejected.
- Insurance:** Artwork will be fully insured for the time of the exhibition. In the event of a claim, value will be assessed by the original purchase amount up to a maximum amount of \$5,000. If a work is valued at over \$5,000, then the owner may wish to seek additional coverage.
- Entry Status:** While most artwork displayed will be borrowed, artwork can be for sale on consignment, if desired. Artwork not for sale will be indicated as NFS on the tag or price list. Since exhibition space is limited, there may be limits as to how much artwork can be displayed.
- Sales:** Contemporary Art Center will retain 30% commission on the sale of artwork. All sales will be deferred to and managed by Contemporary Art Center. Commission checks of 70% of the sale will be mailed to patrons within 30 days following the exhibit closing date. Sold artwork will be indicated by a red dot and must remain on display until the end of the exhibit.
- Registration:** An **Exhibitor Registration Form** is provided on the CAC website for digital submissions at <https://peoriacac.org/registration-form/>. Emailing the information to cac@peoriacac.org is also an option. See the following page for what information is required.
- An **Identification Tag** must be filled out online, printed out and accompany / attached to artwork when dropped off. There will also be identification tags in the gallery to fill out. Contact Contemporary Art Center staff if there are obstacles to submitting online.
- Please register the artwork by Friday, December 19 by midnight.**
- Artwork Delivery:** **December 12-13; 16-20; 23** – hours: 11-5:00; except on the 12th, 19th and 23rd when artwork may be delivered as late as 8:00pm.

Contact Contemporary Art Center staff for additional drop off times if necessary. Identification Tag **must** accompany / be attached to artwork. Tags will also be available at CAC when dropping off work. Artwork arriving later than December 23 may not be displayed.

Viewing Hours: Regular viewing hours are Tuesday-Saturday 11-5:00, during evening events and during First Friday events 5-9:00pm

1st Fridays: An evening opportunity for viewing is 1st Fridays occurring on **Friday, January 2 & February 6**, 5:00pm – 9:00pm. Barara Hoffman will share about Ken's work at 6:30 on January 2.

Reception: Another evening opportunity for viewing will be the Art Reception on Saturday, January 17, 6:30-8:30 pm.

Artwork Retrieval: Artwork may be retrieved starting Tuesday, February 17 through Saturday, February 21, 11-5:00pm and till 8:00pm on February 19 & 20. Contact Contemporary Art Center staff for additional retrieval times if needed. Artwork not retrieved during that time period will be stored.
